DATA WE COLLECT

When you use our Service, you may be asked to provide personal data used to contact or identify you. <https://stokvistapes.nl/> collects the following data:

- Usage Data
- Name
- Email Address
- Phone Number

Usage Data includes:

- Internet Protocol (IP) address of the computers accessing the site
- Website requests
- Referring web pages
- Browser used to access the website
- Time and date of access

HOW DO WE COLLECT DATA?

<https://stokvistapes.nl/> collects and receives information from you in the following ways:

- When you fill out a registration form or otherwise provide your personal data.
- When you use our Service.

Your information is retained for 120 day(s) after you deactivate your account. Your data may be retained longer for reporting or record-keeping in accordance with applicable laws. Data that does not personally identify you may be stored indefinitely.

HOW DO WE USE YOUR DATA?

- To provide and maintain our Service, as well as monitor the usage of our Service.
- For other purposes. Stokvis Tapes Benelux B.V. uses your data for analytics to identify usage trends or evaluate the effectiveness of our marketing campaigns when deemed appropriate. We use your data to evaluate and improve our Service, products, services, and marketing efforts.
- To manage your account. Your personal data may grant access to several features of our Service available to registered users.

COOKIES

Cookies are small text files placed on your computer by websites you visit. Websites use cookies to help users navigate efficiently and perform certain functions.
